
## Letter from the Vice President, K. Terry Jackson, Jr.

### **ANOTHER LHA REGIONAL MEETING A SUCCESS**

In an effort to reach all residents around Lake Hartwell, LHA will continue to hold meetings in different regions of the lake. For the convenience of residents in Georgia, on May 30, LHA held a regional meeting in Hartwell. Approximately 50 members and guests attended the LHA meeting at the Adult Learning Center. The theme of the meeting was a focus of safety on the lake. After a welcome and introductions, Terry Jackson Jr, LHA Vice President, kicked off the meeting with a brief overview of the recent activities of the association. Jackson, also a Captain with TowBoatUS, provided attendees with information regarding the safety benefits of a TowBoatUS membership. The meeting also included updates from Bill Fogerty of Hart County Property Owners for their next meeting on June 17 and from Larry Cole of US Coast Guard Auxiliary for their upcoming Boating Safety Course on June 22 in Hartwell, GA. The featured speakers of the evening were representatives of the Georgia Department of Natural Resources, Law Enforcement Division: Tim Vickery, Ethan Franklin and Brandon Pierce.

Franklin captivated the audience as the main speaker where he outlined the divisions, the mission and vision of the agency. He stated that the agency has a lot of land to cover with over 37 million acres, 63 Georgia state parks & historic sites, 132 wildlife management areas, and 11 public fishing areas. Game wardens patrol 16,000 miles of rivers, 500,000 acres of impounded waters, and 100 linear miles of coastal shoreline out to 200 miles offshore.





Franklin also reported that Georgia has almost 333,000 registered boats. In the year 2021, 34,505 vessels were checked with 7,033 boating violations and 251 BUIs. There were 122 boating incidents with 60 drownings. Franklin also shared updates on the technology being used by the Law Enforcement Division with side scan sonar, sector scan and remotely operated vehicles. Another topic reported by Franklin was the financial side of the agency. In 2021, the agency was funded with \$23,518,437 from state funds, \$3,716,793 from federal funds and \$427,922 from other sources. The total cost to hire, train, equip, and maintain a new game warden is \$151,680.

#### **DON'T FORGET YOUR LIFE JACKET (PFD)**


South Carolina requires all children under 12 years of age to wear a USCG-approved Type l, ll lll or V PFD while onboard a vessel less than 16 feet long. The PFD must be fastened and of proper size for the child. In Georgia all children under 13 years of age must wear a USCG-approved life jacket. This rule also applies to canoes, kayaks and paddle boards in South Carolina and Georgia.

ALL vessels (this includes kayaks, canoes and paddle boards) are required to carry at least one Coast Guard approved life jacked for each person on board. The jacket should be without rips, tears, or deterioration. If your boat is over 16 feet in length, you are also required to carry a Type IV (throwable) flotation device on board. This can be either a USCG approved boat cushion or USCG approved throwing ring. For paddle boarders there is a belt-pouch type inflatable PFD available, but it must be worn by the person, to meet the life jacket requirement. Also remember that when kayaking, canoeing or paddle boarding you must also carry a whistle for emergencies

EVERYONE on board a personal watercraft (popularly know as "jet skis") and anyone being towed behind a vessel must wear a Coast Guard-approved properly fastened and fitted life jacket,

Life jackets do not expire, but wear and tear and prolonged exposure to elements eventually make life jackets unfit for use The foam progressively loses its buoyancy and ability to effectively keep the head above water.

Make sure the life jacket fits. On the inside back of every life jacket it states whether it is USCG approved, the type of jacket (l, ll, lll or V), the size (S,M,L or XL) and the chest size range for that jacket. Children's jackets also include weight range for the jacket. Life jackets for infants and toddlers have a neck support at the back of the jacket. It is imperative that any life jacket worn by a child be a good fit. If the life jacket is too large and there is a boating accident or the child falls out of the boat, the child can slide out of the jacket. Unfortunately this has happened before. If you are boating with friends make sure they have life jackets for children, otherwise it is wise to invest in one. Sometimes young children fight having to put on a life jacket, but most "puddle jumper" type swim vests are more comfortable and the child doesn't mind wearing them. Just make sure that it is stamped USCG approved. Not all of these types of swim vests are approved by the coast guard. The "puddle jumper" type vest also works well if your child is playing around or in the water. Arm floaties are not USCG approved and are not recommended for any type of vessel. Be safe not sorry.



#### **TOW BOATS**

How many times have you heard it?--It's a boat....things break. It happens more than you think. New boats or old boats. You are not always near your home dock or at a convenient time or place to call a friend if something happens. Is there another alternative? Absolutely. A TowBoatsUS membership. It's kind of like AAA for cars, but on the lake. The Lake Hartwell TowBoats are piloted by USCG licensed captains. There are usually (3) boats stationed around the lake, so response time is

very reasonable for a lake this size. It's not just (unlimited) towing...TowBoats membership also provides fuel delivery, battery jumps or even a soft ungrounding. Membership is for any recreational boat you own, borrow or charter. And if there is a serious issue, like a sunken boat, TowBoats can also provide salvage and boat recovery work (this would be insurance related).

#### Let's Draw the Line . . .

#### Boundary Line Markings and Proper Uses of Public Land at Hartwell Lake



#### Introduction

The Hartwell Lake project annually provides a source of recreation of more than 13 million visitor days of use.\* With 56,000 acres of water, 23,530 acres of land and a shoreline of 962 miles, Hartwell Lake is one of the Southeast's largest and most popular public recreation lakes. Sound management of this resource is necessary to protect and preserve the project for future generations while providing quality recreation opportunities for today's visitors. Management must insure a balance between the recreation user, the environment, and the conservation of project resources. Consideration must also be given to possible conflicts of use between the general public and the owners of private property adjacent to the project.

#### **Private Use**

The Lakeshore Management Plan furnishes guidance for the protection and preservation of the desirable environmental characteristics of the Hartwell Lake shoreline. Copies of the plans are available from the Resource Managers Office. Public land adjacent to the lake is delineated into different areas of use. This designation of public land allows the District Engineer to approve specific types of private use in certain areas around the lake. This private use is controlled through a permit/license program which may allow individuals with approved access to public land to construct and/or install specific facilities, such as a boatdock, water and electric lines. Although private facilities may be authorized, the ownership of adjacent private land does not convey any exclusive rights to the use of public land. The placing of structures or special use of public land without prior written authorization or contrary to the terms of the authorization, may constitute an encroachment.


An encroachment is the construction, placing, or continued existence of any structure or item of any kind under, upon, in, or over the project lands or waters and/or the destruction, injury, defacement, removal or any alteration of public property including natural formations, historical and archaeological features, and vegetative growth unless said activity is authorized in writing.


Past experience has proven that lot pins do not always agree with the established boundary line. In order to prevent encroachments, we advise adjacent property buyers to obtain the services of a licensed surveyor to verify the property line prior to purchase.

The Corps of Engineers requests the help of all citizens in preventing encroachments on the public land around Hartwell Lake. To assist in identifying the public property at Hartwell, an extensive boundary line maintenance program exists which includes the brushing out and painting of the boundary line every 3 to 5 years.

#### **Boundary Line Witness Markings**

"Painting of the line" actually means painting witness trees near the boundary line. At Hartwell Lake orange paint is used to paint the witness trees along the 810 miles of boundary. Drawings 1 through 4 illustrate the different types of markings and describe their meanings.





#### Questions

If you have questions about the location of the boundary line, contact the Hartwell Lake Resource Manager's Office, (404) 376-4788. A field appointment with a Corps ranger can be scheduled to assist you in locating the boundary line or in answering any other questions you may have concerning encroachments and our permit/license program.

## **NO RAIN, LAKE IS DROPPING...**

According to the Corps of Engineers website for Lake Hartwell lake level forecast ("Declaration"), the lake is forecast to enter Stage 1 Drought condition around 24 August. The management plan of the lake calls for the lake to be at 660' MSL this time of year, and for the next few months. But that assumes we get 'typical' rains which we have not received. Towards the end of August, the level is forecast to drop below 656' (the Drought 'Trigger' Level). This article is a 'heads up' and not the official press release that the Corps typically does. So we can all be looking for that press release if we continue to not receive any rain. And as a reminder, the level of Lake Hartwell is not managed as its own singular entity. Rather it is tied to weather conditions and lake levels for a couple more lakes down towards Savannah. It is most directly tied to Lake Thurmond. The lake level projection is updated weekly around Wednesday. You can find the info at this website location: https://water.sas.usace.army.mil/cf/declarations.htm. For those that need to move their docks to 'chase the lake', this site is very beneficial to helping you plan your dock moves. In addition, the Corps has excellent information regarding the Drought Plan and Pool Schematics (relative lake levels). Check it out!


